September 25, 2017**

Mayor Weiss called the meeting to order.

After the Pledge of Allegiance, Mayor Weiss asked for **approval of the September 13, 2017 Public Hearing minutes. Councilman Mollaun made a motion to approve the minutes. With a second by Councilman Bowell, the motion carried by roll call: Abbott-Aye; Bowell-Aye; Karsteter-Aye; Libbert-Aye; McCool-Aye; Mollaun-Aye; Wilson-Aye. The motion passed 7-0.**

Chief Deputy CT Walters presented **Ordinance 2017-7 titled: Ordinance for Appropriations and Tax Rates (2018 Budget)** for adoption, explaining that there were no comments/questions at the Public Hearing of September 13, 2017 and everyone has had ample time to present concerns. At 5:50 pm Councilman Karsteter made a motion to approve Ordinance 2017-7 with unanimous consent to waive all further readings. Councilman Libbert asked if someone voted Nay, would the 2018 Budget Ordinance still pass. City Atty. Smart stated that it would still pass. With a second by Councilman Abbott, the motion carried by roll call: Abbott-Aye; Bowell-Aye; Karsteter-Aye; Libbert-Nay; McCool-Aye; Mollaun-Aye; Wilson-Aye. The motion passed 6-1.




