

GOLF CART USE IN THE CITY OF GREENDALE

- 1) "Golf Cart" means a commercially manufactured (4) wheeled motor vehicle originally and specifically designed and intended to transport one (1) or more individuals for the purpose of playing the game of golf on a golf course and that has not been modified in any fashion to increase speed.
- 2) No person shall operate a golf cart within the City unless the operator holds a **VALID driver's license.**
- 3) No person shall operate a golf cart within in the City unless the golf cart is registered with the City of Greendale.
 - a. January 1st through March 31st is \$25.00
 - b. April 1st through Dec 31st is \$60.00 for a previously registered golf cart
 - i. If it is a newly purchased golf cart, proven with a bill of sale, it is only \$25.00
- 4) A copy of the individual's driver's license (owner) and proof of insurance/ financial responsibility in the amount not less than the minimum required by Indiana Law (§9-25-4) for a motor vehicle are required at the time of registration. ***(Copies of proof of insurance and driver's license(s) will be kept on file with the Clerk Treasurer.)***
- 5) No person shall operate a golf cart before sunrise or after sunset within the City unless it is equipped with **head lights, tail lights, brake lights, and turn signals.**
- 6) A Police Officer must AFFIX THE PERMIT STICKER on the BACK LEFT REAR of the golf cart so that it is visible from behind. * All registrations expire on December 31st of each year.

7) Golf carts may be operated on authorized streets in compliance with the City Ordinance and all other applicable state traffic laws and regulations. Golf cart may operate between the hours of 7:00am and 12:00am (midnight) local time.

8) The golf cart SHALL NOT BE OPERATED ON THE FOLLOWING PRIVATE ROADS OR HIGHWAYS: INTERSTATE I-275 (including the entrance and exit ramp), US HIGHWAY 50, INDIANA SR 1, STATE LINE ROAD, OBERTING ROAD, RIDGE AVE, and BELLEVIEW DRIVE.

a. A person MAY operate a golf cart across Ridge Ave at the traffic light at the intersection of Brown St and Ridge Ave and the traffic light at the intersection of Probasco St and Ridge Ave.

9) Any person who violates City Ordinance shall be subject to a fine of:

a. First Violation \$50.00 in the same calendar year

b. Second Violation \$100.00 in the same calendar year

c. If a person is cited for a violation of the City Ordinance for a third time in any calendar year, that person may be subject to a fine of \$200.00 and the registration of the golf cart that the person was operating at the time of the citation and the registration for any golf cart(s) registered by that person shall be revoked and the golf cart(s) may not be registered for a period of one year.
